The Board of County Commissioners met on this day in regular session at the office of the Wyandot County Board of Commissioners with the following members present: Mr. David T. Courtad, Mr. Brad L. Batton, and Mr. William J. Clinger. Minutes of the previous meeting were read approved.

IN THE MATTER OF SETTING A PUBLIC HEARING RESTRICTING THE CONSTRUCTION OF ECONOMICALLY SIGNIFICANT WIND FARMS, LARGE WIND FARMS, AND LARGE SOLAR FACILITIES WITHIN SPECIFIC UNINCORPORATED AREAS WITHIN WYANDOT COUNTY

RESOLUTION

WHEREAS, it is the desire of this Board to set a date, time, and location for the Public Meeting on the designation of Antrim, Crawford, Eden, Jackson, Marseilles, Mifflin, Richland, Ridge, and Salem Townships as restricted areas to prohibit the development of economically significant wind farms, large wind farms, and large solar facilities as outlined in Senate Bill 52;

NOW, THEREFORE, BE IT

RESOLVED, that this Board of Commissioners of Wyandot County hereby set, the date, time, and location of the public meeting on the designation of Antrim, Crawford, Eden, Jackson, Marseilles, Mifflin, Richland, Ridge, and Salem Townships as restricted areas to prohibit the development of economically significant wind farms, large wind farms, and large solar facilities as outlined in Senate Bill 52,

RESOLVED, pursuant to ORC Section 303.58, the Wyandot County Board of Commissioners must publish in a newspaper of general circulation within the County, the required notice, of the date and time of the regular meeting to be held on July 31st, 2023, at 5:00 PM, at which the Townships' resolution would be considered; and,

RESOLVED, the Clerk to the Board of the Commissioners is hereby authorized and instructed to certify copies of this resolution, required map and the notice of the proposed restricted area all school districts, municipal corporations, and boards of township trustees located in whole, or in part, within the boundaries of the restricted areas. He also shall post a map showing the boundaries of the restricted area at all public libraries within the county, the Wyandot County Engineer, the Wyandot County Auditor, the Wyandot County Prosecutor, other agents in line with this action, and be it further

RESOLVED, that it is found and determined that all formal action of this Board concerning and relating to the adoption of this resolution were taken in an open meeting of this Board, and that all deliberations of the Board and any of its committees that resulted in such formal actions, were in meetings open to the public, in compliance with the law.

IN THE MATTER OF RESTRICTING THE CONSTRUCTION OF ECONOMICALLY SIGNIFICANT WIND FARMS, LARGE WIND FARMS, AND LARGE SOLAR FACILITIES WITHIN SPECIFIC UNINCORPORATED AREAS WITHIN WYANDOT COUNTY

RESOLUTION

WHEREAS, after receiving resolutions from the Board of Township Trustees of Antrim, Crawford, Eden, Jackson, Marseilles, Mifflin, Richland, Ridge, and Salem stating their desires to preserve each of their agricultural lands by preventing large tracts from being removed from agricultural use by prohibiting the construction of any economically significant wind farms, large wind farms, or large solar facilities throughout the unincorporated areas of the county as outlined in Ohio SB52,

WHEREAS, the Board of County Commissioners have the ability to adopt a resolution establishing restricted areas prohibiting the construction of economically significant wind farms, large wind farms, and large solar facilities within the County as outlined in Ohio Senate Bill 52 which was approved during the 134th Ohio General Assembly; Section 303.58 of the Ohio Revised Code;

NOW, THEREFORE, BE IT

RESOLVED, the Board of Commissioners of Wyandot County Ohio does hereby designate of Antrim, Crawford, Jackson, Marseilles, Mifflin, Richland, Ridge, and Salem Townships as restricted areas prohibiting the construction of any economically significant wind farms, large wind farms, or large solar facilities throughout the unincorporated areas of the county as outlined in Ohio SB52,

RESOLVED, the Board of Commissioners of Wyandot County Ohio does hereby designate Eden Township as restricted area prohibiting the construction of large solar facilities throughout the unincorporated areas of the county as outlined in Ohio SB52,

RESOLVED, the Clerk to the Board of the Commissioners is hereby authorized and instructed to certify copies of this resolution, required map and the notice of the proposed restricted area all school districts, municipal corporations, and boards of township trustees located in whole, or in part, within the boundaries of the restricted areas. He also shall post a map showing the boundaries of the restricted area at all public libraries within the county, the Wyandot County Engineer, the Wyandot County Auditor, the Wyandot County Prosecutor, other agents in line with this action, and be it further;
